<u>ORDER</u>

The proposal for modifying the existing regulation of the course B.Sc.-M.Sc. (Integrated) clause 15 of the Academic Hand Book 2013 was placed in the 125th Academic Council meeting held on 10/07/2015. The Committee has approved the proposal with certain modifications.

In consonance with the decision of the Academic Council meeting held on 10/07/2015, sanction is accorded to amend the clause15 of the regulation of M.Sc. (Integrated) course as follows:

Existing Regulation	Modified Regulation
On receipt of the list of newly admitted students, the Dean shall allot each student to a teacher, who will be the 'Advisor', to the student in all academic matters, upto the sixth semester. Thereafter an Advisory Committee consisting of 4 members (minimum) will be formed by the Dean. A major Advisor and 3 other members should be there. The Major Advisor should be from Kerala Agricultural University or from the Participating Institutions. The scientist of Kerala Agricultural University serving as members of the Advisory Committee should be approved PG teacher as per the KAU norms.	On receipt of the list of newly admitted students, the Dean shall allot each student to a teacher, who will be 'Advisor' to the student in all Academic Matters, upto 6 th semester. Thereafter an Advisory Committee consisting of 4 members (minimum) will be formed by the Dean. A Major Advisor and three other members should be there. From 2012 Admission onwards, the Major Advisor should be from Kerala Agricultural University, any reputed institution involved in concerned research field or from the Participating Institutions. The scientists of Kerala Agricultural University serving as members of the Advisory Committee should be approved PG teachers as per the
	KAU norms

From 2012 admission batch onwards, this modification is applicable only to B.Sc.-M.Sc. (Integrated) Biotechnology course and not for B.Sc.-M.Sc. (Integrated) climate change Adaptation course.
