### ORDER

A proposal for Modification in the mode of presentation and approval of technical programme of research work and conduct of defence seminar of M.Sc./ Ph.D. programme was approved by the 60<sup>th</sup> meeting of the Board of Studies (Faculty of Agriculture) held on 24.10.2017 and was placed before the 131<sup>st</sup> meeting of Academic council held on 22.02.2018. The council has approved the same with effect from 2018 PG Admission with the following modifications:

- 1. In group (vi) Commerce and Banking, the term 'commerce' will be replaced by 'Co-operation'
- 2. These meetings will be co-ordinated by the Professor (R.C.) and will be chaired by the Dean / Assoc. Dean of the college. All Faculty members of the respective departments (under that group), advisory committee members, Director of Research, Director of Planning, Director of Extension, Director (Academic & P.G. Studies), or their representatives are to be present. HoD's of all other Depts. in the campus, Project co-ordinators and subject experts also will be invited. The terms 'ADR also will be invited for these meetings' is deleted.

Accordingly orders were issued Vide 2<sup>nd</sup> paper read above. While considering the confirmation of minutes the following modifications were also suggested and approved by the 132<sup>nd</sup> meeting of Academic council held on 28.09.2018, and the council has modified the decision taken in the 131<sup>st</sup> meeting of Academic council held on 22.02.2018 to the following extent.

(i) Added the terms "Respective Project Coordinators will also be invited during the presentation of the technical programme".

(ii) Invitation should be sent to the project coordinator concerned for the defense seminar and a copy of the thesis abstract should be given to Director of Research at the time of thesis submission.

In consonance with the decision of  $132^{nd}$  meeting of Academic council held on 28.09.2018, sanction is hereby accorded to effect the following modifications in the mode of presentation and approval of technical programme of research work and conduct of defence seminar of M.Sc./ Ph.D. programme with effect from 2018 PG admission onwards, in the Faculty of Agriculture.

After approval in the group meeting, M.Sc. students have to submit ten copies of the finally corrected and duly signed copies of the technical programme to the Professor (R.C.) for obtaining the administrative and technical sanction from the Director of Research.

The FRC will be convened soon after the group meetings, (Preferably by the second month of second semester). The Ph.D. scholars have to submit sixty hard copies of their technical programme (group meeting approved) within a week to the Professor (R.C.) for forwarding to the members of the FRC. The FRC members can communicate their comments / remarks on these Ph.D. projects to the Professor (R.C.) and to the major advisors. The Professor (R.C.) will be presenting these comments to the FRC meeting along with the reply of the major advisor. No individual presentations of scientists will be made and final decision will be taken in the FRC meeting.

For getting the approval of these projects in the Academic council, all the Ph.D. Scholars will have to submit another forty copies of the corrected technical programme to the Professor (R.C.), immediately after the FRC.

# Minor modifications in the Technical programme:

Permission to make minor modifications needed during the course of the research work can be granted by the Professor (R.C.) for both M.Sc. and Ph.D. students on the basis of the request of the advisory committee of a student.
