KAU-Acad– Proposal for modification of attendance(Clause 21.1 para-2) of UG regulations – modified – Orders issued.

ORDER

As per the order read 1st above, the clause 21.1 para II of UG regulations 2013 was amended by adding the following para to the already existing regulation.

"A student who is absent in semester final examination due to accident, hospitalization, contagious diseases and any other genuine reason recommended by the Head of Institution, but has secured minimum requirement of attendance will be awarded grade point of I*. In such cases, the student need not REPEAT the course, but only to attend the final examination (Re-exam) in which he/she was absent and in these cases, the credit hours will not be considered for calculating GPA/OGPA. In all other cases, the students will be awarded I".

A proposal to delete the above said modification was placed before the 132nd meeting of Academic council held on 28.09.2018. The council has approved the proposal and decided to award with F (Failed) instead of I* or I to such students to re-register the course and appear for theory and practical examinations alone and the regulation will be implemented with effect from Academic year 2016-17 onwards.

In consonance with the decision of the 132nd meeting of Academic council held on 28.09.2018 the following orders are issued.

The clause 21.1 para II of UG regulations 2013 "A student who is absent in semester final examination due to accident, hospitalization, contagious diseases and any other genuine reason recommended by the Head of Institution, but has secured minimum requirement of attendance will be awarded grade point of I*. In such cases, the student need not REPEAT the course, but only to attend the final examination (Re-exam) in which he/she was absent and in these cases, the credit hours will not be considered for calculating GPA/OGPA. In all other cases, the students will be awarded I" is hereby deleted and has decided to award with F (Failed) instead of I* or I to such students to reregister the course and appear for theory and practical examinations alone.

The above said modified regulation will be applicable with effect from 2016-17 Academic year admission onwards.
