The committee has submitted the report on the above said case and recommended to permit the students who secured GPA 8 or less to appear for the improvement examination (only once) with succeeding batches for a course. This provision is applicable only upto 4<sup>th</sup> semester. The improvement examination for a course registered should not exceed the maximum permitted credit load per semester. Registration for the improvement examination can be canceled before final theory examination. The marks obtained in the improvement examination will be considered as the final mark. An examination fee of Rs. 1000/- will be charged per course and it will not be refunded at any circumstances.

The report of the committee was placed before the 132<sup>nd</sup> meeting of the Academic Council held on 28.09.2018 and the Council has approved the recommendations with a condition that the mechanism for implementation will be placed in the next Academic Council.

In consonance with the decision of the 132<sup>nd</sup> Meeting of the Academic Council held on 28.09.2018 the following orders are issued.

- \* Sanction is hereby accorded to permit the students who secured GPA 8 or less to appear for the improvement examination (only once) with succeeding batches for a course.
- \* This provision is applicable only upto 4<sup>th</sup> semester.
- \* The improvement examination for a course registered should not exceed the maximum permitted credit load per semester.
- \* Registration for the improvement examination will be canceled before final theory examination.
- \* The marks obtained in the improvement examination will considered be as the final mark.
- \* An examination fee of Rs. 1000/- will be charged per course and it will not be refunded at any circumstances.
